SCG was engaged to deliver security advisory services to the WA Department of Justice for a 512-bed expansion of WA's maximum-security male prison.

We were subsequently engaged to provide full security and communication design services for a further 344-bed expansion as part of the stage one inside the wire expansion, and a security upgrade of the master control room and sitewide security systems.
